This outline is a general summary of benefits available, however we recommend you contact Summit America in order to tailor a plan to best fit your athletic program needs.



Standard Policy Benefits

- **\$25,000 excess basic accident medical maximum with a 2 year benefit period**
- **\$10,000 AD&D benefit for covered injuries (other maximums available)**
- **\$25,000 Dental Maximum**
- **On-line electronic claim form**
Complete incident reports on-line and submit quickly and easily. There will be no need to mail claim forms or track down students for signatures.
- **Dedicated examiner and customer service representative**
The participating institution will have a dedicated examiner to speak with each and every time they need assistance with claims or benefit determinations
- **ID cards issued for athletic use**
ID cards with preferred network logos will be issued to the school for use by student athletes that have been injured as part of a covered event. Presenting the ID card to providers at the time of service will identify available network discounts and help increase the timeliness of submission and processing of claims.
- **24 hour on-line access to paid claims**
The participating institution will be granted 24 hour on-line access to view real-time claims status



Optional Benefits

- **Expanded Medical Benefit**
Allowing for sports related injuries such as tendonitis, stress fractures, bursitis, etc.
- **HMO/PPO Benefit**
Allowing for expenses denied or reduced by the primary carrier for non-compliance with their plan guidelines regarding provider usage
- **Re-Injury Benefit**
Allowing for coverage of re-injury or aggravation of an injury sustained prior to the effective date of the policy
- **Heart or Circulatory Malfunction Death Benefit**
If an Insured suffers loss of life resulting from Heart or Circulatory Malfunction (as defined in the policy), within 90 days from the date of participating in a scheduled game or supervised practice relating to the first diagnosis, we will pay, on behalf of the Insured, a lump-sum benefit.
